Motions

14-086 Motion presented by Councillor Novoselsky: That the following Proclamation be adopted by the Revere City Council:

Proclamation

Whereas: Sixty-nine years ago, six million Jews were murdered in the Nazi Holocaust as part of a systematic program of genocide, and millions of other people perished as victims of Nazism;

Whereas: The people of the City of Revere should always remember the atrocities committed by the Nazis so that such horrors never are repeated; and

Whereas: The people of the City of Revere should continually rededicate themselves to the principle of equal justice for all people; and

Whereas: The people of the City of Revere should remain eternally vigilant against all tyranny, and recognize that bigotry provides a breeding ground for tyranny to flourish; and

Whereas: April 28 has been designated, pursuant to an Act of Congress and Internationally, as a Day of Remembrance of Victims of the Nazi Holocaust known as Yom Hashoah; and

Whereas: It is appropriate for the people of the City of Revere to join in the International Commemoration;

Now, Therefore, I, Daniel Rizzo, Mayor of the City of Revere, do proclaim that, in memory of the victims of the Holocaust, and in the hope that we will strive always to overcome prejudice and inhumanity through education, vigilance and resistance, that the week of April 27 through May 3, 2014, is hereby designated as the Days of Remembrance of the Victims of the Holocaust.

This Proclamation is given at Revere City Hall this Twenty-Eighth day of April, in the year of Our Lord two thousand and fourteen.
